



IMPORTANT INFORMATION ABOUT PROPOSED INCREASES IN ELECTRICAL RATES

APPLICATION NO. A.08-04-001

In compliance with California Public Utilities Commission (CPUC) decisions, Southern California Edison Company (SCE) filed its April 2008 Energy Resources Recovery Account (ERRA) application with the CPUC on April 1, 2008. This application is referred to as A.08-04-001.

In this application, SCE demonstrates that during the period of January 1, 2007 through December 31, 2007: (1) its recorded fuel expenses, energy expenses and contract administration were reasonable; (2) its dispatch of generation resources and related spot market transactions complied with SCE's Commission-approved Procurement Plan; and (3) its other operations subject to Commission review were reasonable.

In addition to presenting SCE's recorded costs for review, this application requests approval to recover the revenue requirement associated with the balances accrued in two memorandum accounts authorized by the Commission.

Compared to revenues at present rates as of April 8, 2008, SCE is requesting a revenue increase of \$13.947 million, or 0.12% in 2009. The following table shows an estimate of proposed revenues and rate changes by customer group.

On an illustrative basis, if total rates change as requested, an average residential electric customer using 700 kilowatt-hours per month in the summer would see an increase of 12 cents per month, from \$105.15 to \$105.27.

THE CPUC WELCOMES YOUR PARTICIPATION AND COMMENTS

The CPUC may schedule evidentiary hearings on SCE's application. Evidentiary hearings are conducted before a Commission Administrative Law Judge, who may be joined by one or more of the Commissioners. At the hearings, sworn testimony is presented by SCE representatives, other parties, and the Commission's independent Division of Ratepayer Advocates (DRA). Evidentiary hearings are open to the public, but only those who are parties of record can present evidence or cross-examine witnesses during evidentiary hearings. The rates approved may differ from those SCE requests.
